## **Trustees' Report**

### **Year ended 31 December 2025**

The trustees present their annual report and financial statements of the charity for the year ended 31 December 2025. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland effective from 1 January 2019.

#### **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

#### **Achievements and Performance**

January 2025 saw the first anniversary of the Union of Barry I/w Carnoustie and Carnoustie Panbride united to form Carnoustie: Trinity Church of Scotland with most of the Kirk Session Teams now in place. This was marked by a Kirk Session Conference, 'A Vision for Mission,' which took place in Panbride Hall that month.

Annette and Mike continued to meet weekly to reflect on progress, share Ministry tasks, and plan for the future. There were four joint Services during the year including a Joint Communion Service in Barry in October.

The Annual Evaluation of the Presbytery Mission Plan for Perth in 2025 restated the vision for a Parish Grouping between Monifieth: South Angus and Carnoustie: Trinity. However, there had been no progress with Monifieth: South Angus regarding the future shape of a Parish Grouping. The future for Barry Church was delayed as the commencement of refurbishment at Carnoustie led to services there being moved to Barry until the works were to be completed in 2026.

The Kirk Session carried out a major data protection review of members, which led to a substantial reduction in the roll. We also lost several Elders through death or retirement, and these factors led to the requirement to substantially rearrange the Elders Districts, a matter that was nearing completion at the end of the year.

#### **Social Activities**

Both the Barry Guild and Carnoustie Guild met regularly and continued to be well supported by members and friends throughout the year. A Joint Guild Dedication service took place at Barry church in September. Barry was the venue for the Barry Community Group charity which met regularly throughout the year to plan and work for community support in the village and surrounding area.

Newton Panbride was the venue for frequent social events, including Coffee and Chat, Needles and Pins, Men's Breakfast, the Carnoustie Friendship Circle, and Panbride Musical Memories. In addition, Panbride Hall and Newton Hall continued to be used on an almost daily basis by the congregation and numerous community run groups.

In June there was a picnic in the Panbride Manse Garden. A putting competition was held at Carnoustie Golf Links putting green which was followed by a BBQ in the Carnoustie Manse and garden. The annual Congregational Day was to the Garden Centre in Stirling, and the George Hotel, Perth for lunch.

#### **Fundraising**

There were various fundraising events in Panbride Hall during the year including Coffee & Pancake Morning and a Christmas Themed Evening with local traders having stalls. The Congregation had a stall at the community Gala Day

selling berries, books, items from Needles & Pins, and £1 Surprise Bags., The Christian Aid Coffee morning took place in the Panbride hall.

The well supported Coffee and Chat continued to meet monthly in Carnoustie Church raising funds for the major internal building project there until the temporary closure of the building at the end of June. During the summer months Barry Guild organised well-attended afternoon teas in Barry Church Hall and a special one at Christmas, all strongly supported by the wider church and community.

#### **Carnoustie Church Refurbishment Project**

Following the closure of Carnoustie Church at the end of June, the building was mostly emptied and items put into storage, and the pews were sold off, largely to the local community. An attempt at repairing the valley gutter was made earlier in the year, but it had not been completed adequately, and the matter was put into the hands of the Law Department of the Church of Scotland. The renewal of the work to proper standards was entrusted to the main project contractors thereafter.

The project itself was put out to tender in July, and a tender accepted during the summer, with the work commencing properly in late autumn. The congregation looked forward to the transformation being due for completion in late spring 2026, with new kitchen, rooms, toilet facilities, flooring, heating and seating.

Thanks to the generosity of our members and the grant giving bodies who made this possible.

#### **Mission**

The congregation provided shoeboxes for Blythswood Care Shoebox Appeal.

During the year various retiring offerings had been taken up for local and national good causes including an offering to the Carnoustie High School Toast Club.

Members of the Pastoral Care Team with appropriate safeguarding qualifications had accompanied Annette to the various care homes in Carnoustie for services, and Mike also led services there in an informal rotation.

The congregation continued to support 1<sup>st</sup> Carnoustie Boys' Brigade and Girls' Association with chaplaincy and visits as well as with the BB Christmas Post. Mike Goss continued to serve as an Officer in the Company Section as well as Company Chaplain, while Annette Gordon continued to serve as Battalion Chaplain. Annette led the Battalion Christmas Carols Service in Stobswell Trinity Church in December. The end of session Awards Service was held during morning worship at Newton Panbride, and the Enrolment Service was held during morning worship at Barry.

Annette also continued as chaplain to 1<sup>st</sup> Carnoustie Scouts and supported them in various events last year, including a visit to the Scouts on Thinking Day to talk about the Abrahamic Faiths, and as a guest at the Explorers' Talent Show in Panbride Hall in November.

During the year, both Carnoustie Church and Newton Panbride Church hosted the Inspiration Orchestra led by Ian White, which included a Christmas Carol Concert at Newton Panbride.

#### **Worship**

Services in Newton Panbride and in Carnoustie continued to be live streamed; the Carnoustie stream was moved to Barry

during the refurbishment. This provided worship both for members of our congregation who were no longer able to attend church and for the wider community. The organists in Carnoustie/Barry and Newton Panbride continued to lead the praise and direct the choirs in those places of worship, and we are grateful for their continued support and initiative for our services.

Bible Studies took place during Lent and during Advent at Panbride Manse. The prayer meeting has continued to meet weekly, usually in a member's home or Carnoustie Manse. A new monthly prayer meeting for families took place. Carnoustie Guild's Bible Study Group continued to meet fortnightly in a member's home, and other informal study and fellowship groups continued to meet.

The Worship Team as well as being involved with Sunday worship also participated in the Holy Week Morning Services. We also maintained rotas of readers who read scripture on a Sunday morning in each of the places of worship ensuring that a mixture of voices was heard.

Carnoustie Church was the venue for the Wednesday evening service during Holy Week, and Newton Panbride continued to host the Morning Reflections in Panbride Hall. Our congregation was well represented at other Holy Week Evening Services in the church buildings of the other denominations in the town, as we continued our partnership with the other Ministers. The Good Friday Walk of Witness was again an ecumenical witness to the community. Easter Day began with the sunrise service by the beach followed by bacon rolls in Carnoustie Church, and an early morning Family Service with breakfast in Panbride Hall. An outdoor Easter service was also held in the West Garden at Barry village in place of the usual morning service in the building.

Our young people from JAFFA continued to meet in Panbride Hall.

In June 2025, we said goodbye to some of our FOG leaders after many years of commitment to our children. After a short delay while Safeguard Training took place and PVGs were acquired, the FOG Squad started back in November with some new leaders.

In December, Mike and Annette led the Service of Remembrance and Hope in Newton Panbride Church. We continued our new tradition of 'Carols around the Christmas Tree' which took place in the Newton Panbride grounds with the congregation being accompanied by Arbroath & Carnoustie Instrumental Band. A well-attended Christingle service was held on Christmas Eve in Barry with funds raised for the High School Breakfast Club. Watchnight and Christmas Day Services were held in Barry and Newton Panbride churches.

In June Carlogie Primary School attended Newton Panbride Church for the End of Term Service and returned in December for the school's Christmas Service.

At the beginning of the year a launch event was held for the publication of 'A History of Panbride,' marking the story of Panbride Church to its closure. In August, the sale of Panbride Church was completed.

### **Flower Ministry**

Flowers are donated by members and friends of the congregation and are given to the bereaved in the community as well as to members who are ill or celebrating a special occasion. At Christmas the Benevolent Funds provided gifts of flowers or plants to members of the congregation who are elderly, have suffered loss or who are infirm.

## **Church Cleaning Teams**

We are grateful to the volunteer cleaning teams for keeping our buildings clean, not only for worship on a Sunday but for both members and the community who use our premises.

## **AV Teams**

The AV Teams ensure our services are live streamed from both Carnoustie and Newton Panbride buildings and that the hymns and readings are projected onto the screens. This enhances worship for those worshipping in person and online.

## **Financial Review**

With the congregation having three worship centres neither income nor expenditure can be compared with previous years.

As at 31 December 2025, 187 (196 - 2024) members (and their families) contributed by means of regular bank standing orders and of these 147 (164 - 2024) were made under the Gift Aid provisions. The total contributed by this method was £92,714 (£93,676). The freewill offering scheme is also encouraged and during the year 40 (40) members (and their families) contributed £12,182 (£12,382) of which £7,498 (£7,956) was under the Gift Aid provisions. Sixteen members contribute by means of annual cheques/BACS transfers.

The 2024 income was enhanced by the inclusion of funds held by the legacy congregations of Barry and Newton Panbride as income of the new union and this resulted in an overall surplus. In 2025 there was no unexpected income to affect the figures in the accounts. There were major stonework repairs carried out on Newton Panbride Church which affected both the General and Fabric Fund while the roof repairs and internal renovation project at Carnoustie Church were funded from specific funds.

The total amount contributed under the Gift Aid provisions amounted to £116,730 (£105,115) as this includes donations to funds other than the General Fund.

The 2024 income was enhanced by the inclusion of funds held by the legacy congregations of Barry and Newton Panbride as income of the new Union and this resulted in an overall surplus. In 2025 there was no unexpected income to affect the figures in the accounts. There were major stonework repairs carried out on Newton Panbride Church with affected both the General and Fabric Funds while the Carnoustie Church roof repairs and internal renovation project were funded from specific funds.

Membership: The Kirk Session carried out a major data protection review of members, which led to a substantial reduction in the roll. The number on the roll at the year-end was 633, a reduction of 234 or 27% on the previous year.

## **Risk Management**

The principal causes for concern are increasing costs and decreasing income and reserves along with an ageing congregation.

Efforts to relieve the position have been undertaken both in controlling costs where possible and focusing on trying to increase members' giving but with inflation continuing at relatively high levels, members' disposable income continues to be eroded.

#### **Reserves Policy**

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted funds of £159,017 (2024 - £194,492) of which £14,391 (2024 - £17,868) had been designated for Fabric Fund and £34,665 (2024 - £55,657) for the Carnoustie Church Project Fund and Carnoustie Church Roof and Buildings Fund. The remaining balance of £109,977 (2024 - £120,143) represents about seven months expenditure and while this is higher than would normally be expected the Trustees are aware of the need

The church also held £377,354 (2024 - £355,857) of restricted funds which have been provided for the purposes specified in Note 12.

#### **Structure, Governance and Management**

The congregation is a registered charity, number SC015146 and is administered in accordance with the terms of the Deed of Constitution (Unitary Form) and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The ministers, who are members of the Kirk Session, are elected by the congregation and inducted by Presbytery.

Under the Unitary Constitution the functions of the Kirk Session are both spiritual and temporal, with responsibility for proposing policy changes as well as overseeing the life, worship and witness of the congregation.

The Kirk Session held 10 meetings over the year.

### **Independent Examiner's Report to the Trustees of Carnoustie: Trinity Church of Scotland Year ended 31 December 2025**

I report on the accounts of the charity for the year ended 31 December 2025 which are set out on pages 10 to 20.

#### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

#### **Basis of independent examiner's statement**

### **Accounting Policies**

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

### **Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) effective from 1 January 2019 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (as amended).

### **Fund accounting**

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

### **Going concern**

The Trustees consider that there are no material uncertainties about the ability of the charity to continue for the foreseeable future and therefore has adopted the going concern basis in preparing these financial statements.

### **Recognition of income**

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received, and the amount can be measured reliably.

### **Donated services and facilities**

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised. On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

**Recognition and allocation of expenditure**

**Interest receivable**

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

Expenditure is included in the Statement of Financial Activities on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure.

**Fixed Assets**

The charity has the right to occupy & use for its charitable objects tangible fixed assets, including the Churches, halls & manses, vested in the Church of Scotland General Trustees. No consideration is payable for use of these assets. Expenditure incurred on repair and maintenance of these assets is charged as resources expended in the SOFA accounts in the period the liability arises.

**Investments**

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year.

**Taxation**

Carnoustie: Trinity Church of Scotland is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

**Cash and cash equivalents**

Cash and cash equivalents include cash in hand and deposits held at 31 December 2025 was £458,741 of which £10,294 was with the Investors Trust.

**Debtors**

Trade and other debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any discounts due.

**Creditors**

Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.
